## THESIS STATEMENT

- 1. Does the Thesis Statement follow the S+D+3R Method? <u>Underline</u> the subject, <u>double</u> <u>underline</u> the <u>direction</u>, and <u>circle</u> each of the 3 reasons.
- 2. Is the Thesis Statement cleverly stated?
- 3. Does the Thesis Statement flow smoothly?
- 4. Is the Thesis Statement parallel in structure?
- 5. Is the Thesis Statement either too short or too long?
- 6. Is the Thesis Statement only 1 sentence long?

#### INTRODUCTORY PARAGRAPH

- 7. Does the writer use an original and clever attention-getter?
- 8. Is the topic of the paper introduced in the Introductory Paragraph?
- 9. Are details clearly and cleverly provided in the Introductory Paragraph to make the paper sound interesting? Do they make sense in the paragraph?
- 10. Is the Thesis Statement clear and obvious in the Introductory Paragraph? Is it the last sentence of the first paragraph?

### BODY PARAGRAPHS

- 11. Do the Body Paragraphs consist of 9 properly-sized paragraphs (5-8 sentences)?
- 12. Are the Body Paragraphs written in the same order as they were in the Thesis Statement?
- 13. Does each Body Paragraph begin with a topic sentence that introduces the topic?
- 14. Does each Body Paragraph talk about one (and only one) specific example?

- 15. Does each Body Paragraph contain interesting and appropriate amounts of detail?
- 16. Does **each** Body Paragraph emphasize the DIRECTION of the overall paper (does it try to convince you to visit their vacation destination)?
- 17. Does each Body Paragraph end with either a TRANSITION sentence or a CONCLUDING sentence?

#### CONCLUSION PARAGRAPH

- 18. Does the Conclusion Paragraph clearly summarize the important information discussed in the paper?
- 19. Is the Thesis Statement re-stated (in different words, using 1 sentence) in the Conclusion Paragraph?
- 20. Is the *persuasive* element of the paper very clear and strong in the Conclusion Paragraph (Do you feel like you want to visit that vacation destination)?
- 21. Does the Conclusion Paragraph contain an obvious (but not too forceful) *call-to-action* (Does the reader ask you to do something now that you've read the paper)?
